The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be SANDMORE, INC. and the business address and location of the Corporation shall be 160 East Lake Brantley Drive, Longwood, Florida 32779.

CORPORATE DURATION

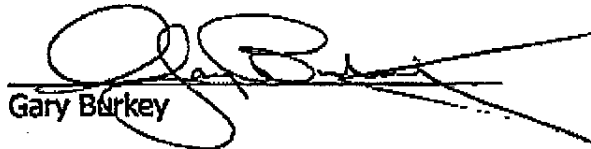

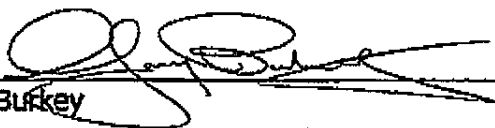
