

ARTICLES OF INCORPORATION

OF

LOTTE ORIENTAL MARKET, INC.

ARTICLE I

NAME OF THE CORPORATION

The name of the Corporation is LOTTE ORIENTAL MARKET, INC.

ARTICLE II

The principal office of the Corporation is located at 1425 West Oakridge Road, Orlando, FL 32809.

ARTICLE III

The street address of the initial registered agent of the Corporation is 1474 Sunshadow Drive, apt. 208, Casselberry, FL 32707, and the name of the initial registered agent at that address is Jun Kang.

ARTICLE IV

The general nature of the business to be transacted by the Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE V

The affairs of this Corporation shall be managed initially by a Board of two (2) Directors. The number of Directors may be changed by amendment of the By-laws of the Corporation. ARTICLE VIII

BY-LAWS

The By-laws of this Corporation shall be adopted by the Board of Directors and may be altered, amended, or rescinded by a majority vote of the Board of Directors.

ARTICLE IX

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one thousand (1,000) shares of common stock (having a par value of \$1.00 per share).
