ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Gazelle Motor Corp.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be:

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000,000 shares of \$1.00 par value common stock which shall be designated as "Common Shares".

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
