**ARTICLE I. CORPORATE NAME**

The name of this Corporation is Midland Oil Company, Inc., and its mailing address is 1310 Gulf Blvd. Suite 20-F, Clearwater, FL 33767.

**ARTICLE II. NATURE OF BUSINESS**

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having a par value of \$ 0.10, (Ten Cents).


## ARTICLE X. PRE-EMPTIVE RIGHTS


