Article 1

The name of this corporation is **Dymka Service Corporation.**

Article 2

The corporation may engage in any and all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes. While pursuing its purposes, the corporation may exercise the powers granted now or in the future by Section 607.0302, Florida Statutes, and by common law.

Article 3

The aggregate number of shares which the Corporation shall have the authority to issue shall be 20,000,000 shares of common stock, each having a par value of \$.001 and 200,000 share of Preferred Stock each having a par value of \$.001 per share.

Article 4

The street address of the place of business of the Corporation is 2020 Burlington Avenue, Apartment # 5, St. Petersburg, Florida 33713. The address of the initial registered office maintained pursuant to Section 607.0501 Florida Statutes is 2020 Burlington Avenue, Apartment # 5, St. Petersburg, florida 33713. The name of the corporation's initial registered agent to receive service of process is Dmitrij Polutaradnev.

Article 5

The number of directors constituting the initial Board of Directors is one. The number of directors may be changed by resolution of the directors as provided in the By-laws. The name of the person who is to serve as Director is:


Article 7


