ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of this corporation is GOLD RUSH OF MARION, INC.

ARTICLE II. DURATION

This corporation shall begin its existence on the 10th day of April, 1998.

ARTICLE III. PURPOSE


