

## ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

## BRUNO ENTERPRISES INC.

I, THE UNDERSIGNED, BEING OF SOUND MIND AND LEGAL AGE, DO HEREBY AGREE TO BECOME A CORPORATION FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA AND PURSUANT TO THE PROVISIONS OF THE LAWS OF SUCH STATE, PROVIDING FOR FORMATION, LIABILITY, RIGHTS, PRIVILEGES, BENEFITS AND OBLIGATIONS CONFERRED AND IMPOSED BY SUCH LAWS ON CORPORATIONS ORGANIZED PURSUANT TO THE PROVISIONS THERE OF, AND DO HEREBY MAKE, SUBSCRIBE, ACKNOWLEDGE AND AGREE TO AND FILE THESE ARTICLES OF INCORPORATION AS FOLLOWS:

## **ARTICLE I**

#### NAME

THE NAME OF THE CORPORATION SHALL BE:

#### ARTICLE II

## NATURE AND DURATION OF CORPORATE BUSINESS

THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES AND UNDER THE LAWS OF FLORIDA. THE CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

## ARTICLE III

## CAPITAL STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE A MAXIMUM OF 7,500 SHARES OF STOCK. THE SHARES OF STOCK AUTHORIZED SHALL BE COMMON STOCK HAVING A PAR VALUE OF \$1.00 PER SHARE.

THE CONSIDERATION TO BE PAID FOR EACH SHARE OF STOCK SHALL BE FIXED BY THE BOARD OF DIRECTORS.

# ARTICLE IV

## PRE-EMPTIVE RIGHTS

EVERY SHAREHOLDER UPON THE SALE FOR CASH OF ANY NEW STOCK OF THIS CORPORATION OF THE SAME KIND, CLASS OR SERIES AS THAT WHICH HE ALREADY HOLDS, SHALL HAVE THE RIGHT TO PURCHASE HIS PRO RATA SHARE THEREOF AT THE PRICE AT WHICH IT IS OFFERED TO OTHERS.

# ARTICLE V
