ARTICLES OF INCORPORATION

OF

PHILLIPS HIGHWAY RESTAURANT, INC.

The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is PHILLIPS HIGHWAY RESTAURANT, INC.
