The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I - NAME

The name of this corporation is **C & M PRODUCTIONS, INC.**

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

1. The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

2. Shall perform contracts, agreements, and arrangements to fulfill or carry out services within the industry of publication and advertising.

3. To develop small-scale publications including, but not limited to, classified ads where people can buy, sell personal items, find work, meet others for possible relationships, and have business advertised in said newspaper.

4. Engage in any and every lawful business whatsoever whether herein mentioned or not complying with the norms, rules and regulations within the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

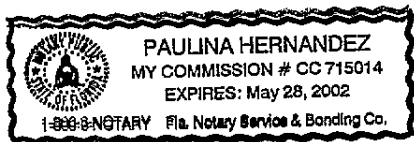

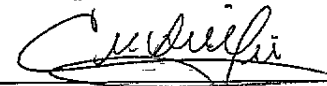
