The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLES I. NAME**

The name of the corporation Shall be:

#### ARTICLE XIV. DISSOLUTION


In the event of dissolution, the assets of the Corporation shall be distributed to the stockholders.



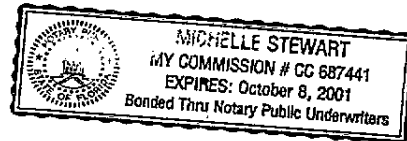
