**ARTICLE I**

**NAME**

The name of the corporation is SOAP BOX, INC.

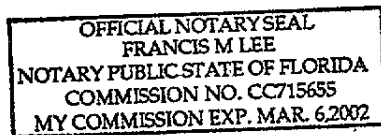
