THE UNDERSIGNED, for the purpose of forming a corporation profit pursuant to the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation shall be KEY EQUIPMENT, INC.

**ARTICLE II - MAILING ADDRESS**

The mailing address of this corporation is as follows:

**ARTICLE III - DURATION**

This corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles of Incorporation by the Secretary of State of the State of Florida.

**ARTICLE IV - PURPOSES**

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

**ARTICLE V - CAPITAL STOCK**

The authorized capital stock of this corporation shall consist of ten thousand (10,000) shares of common stock, having a par value of \$.01 per share.

**ARTICLE VI - INITIAL REGISTERED AGENT AND REGISTERED OFFICE**

This corporation exercises its right, pursuant to Section 607.0902(5), Florida Statutes, to avoid the provisions pertaining to control-share acquisitions contained in Sections 607.0902, 607.1302(c) and 607.1320, Florida Statutes.

**ARTICLE X - INCORPORATOR**

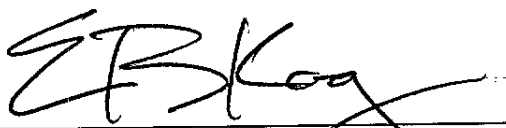

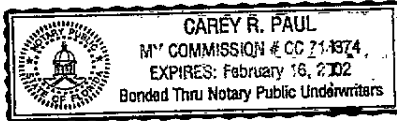
