The undersigned, acting as Incorporator of BUREAU OF MEDICAL INFORMATION, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is BUREAU OF MEDICAL INFORMATION, INC. and the street address of the initial principal office of the Corporation is 10110 Southwest 16th Place, Davie, Florida 33324.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue 200,000 shares of Common Stock. The shares shall consist of 100,000 shares of Group A Voting Common Stock, with no par value per share, and 100,000 shares of Group B Non-Voting Common Stock, with no par value per share. Each Group of shares shall be identical in all respects, except the Group B Non-Voting Common Stock shall carry no right to vote for any matter presented to the shareholders.
