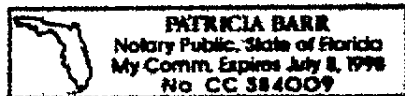
1. The name of the Corporation is: **JAM RENT-A-CAR, INC.**

5. This Amendment has been unanimously approved by the Shareholders pursuant to Florida Statute, 607.1003 and such vote was sufficient for approval of this Amendment.


