Dear Mr. Toner:

In reference to our conversation of 01/03/2001: I would like to restate that neither I or my CPA ever received a notice or any correspondence concerning the Uniform Annual Corporate Report from the Department of State for the year 2000. The first information which I received was the letter in late July, which I forwarded to my CPA. He promptly notified me that the letter was stating that my renewal was in arrears and needed to be forwarded promptly with a \$400 late fee.

My CPA explained that if I sent in a letter with the check for \$150 explaining that this document had not been received by either of us and that the reason was likely due to my relocation, your office would likely accept this and also accept the \$150 and reinstate the corporation.

What has followed has seemed to be a great deal of misunderstanding at both ends. From what I can gather, the first letter of explanation, along with the check for \$150 was not received by your department, just the check. What happened to my original note we'll likely never find out. Hopefully this will suffice for your office to reinstate my corporation for the year 2000.

I am also enclosing a check for \$150 for the year 2001 so that my understanding is that I'll then be paid through January 2002.
