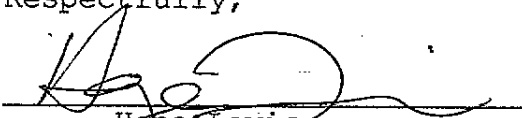

ARTICLES OF INCORPORATION  
OF  
FAMILY FUN PUBS OF CLEARWATER, INC.

ARTICLE ONE

The name of the corporation is FAMILY FUN PUBS OF CLEARWATER, INC. and its principal office and mailing address is 1857 Venetian Point Drive, Clearwater, Fl. 33755.

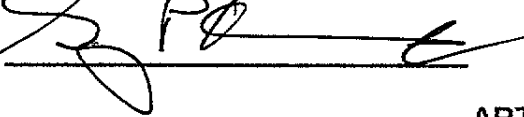
