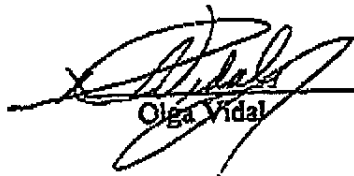
**ARTICLE X-INCORPORATOR**
