The undersigned subscribers to theses Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is **Doug & Trish Hendry, P.A.** and its principal office and mailing address is: **9915 TAMIAMI TRAIL NORTH SUITE 2, NAPLES, FLORIDA 34108.**

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is: Real estate sales and managment. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds.
