**ARTICLE I - NAME**

The name of this Corporation is Parnasa, Incorporated.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence. The Corporation existence shall commence with filing with the Secretary of State.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares which this Corporation is authroized to have outstanding at any time is One Hundred (100) shares of common stock with no par value.

**ARTICLE V - INITIAL REGISTERED  
OFFICE AND AGENT**

The initial registered office of this Corporation shall be 18020 N.E. 9th Place, North Miami Beach, Florida 33162, and the initial registered agent of this Corporation at such office shall be Robert Brass, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process. The principal office and the registered office are the same.

**ARTICLE VI - INITIAL BOARD OF DIRECTORS**

The initial Board of Directors shall consist of 2 members. The number of directors may be increased or decreased from time to time by vote of the Stockholders, but in no case shall the

number of directors be less than 2 nor more than 5. The names and addresses of the directors constituting the initial Board of Directors are:

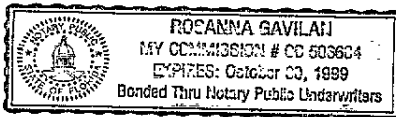
