ARTICLES OF INCORPORATION OF MERC MODELING, INC.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. NAME: The name of the corporation is MERC MODELING, INC.

- 2. PRINCIPAL OFFICE; MAILING ADDRESS: The principal office and mailing address of the corporation is 485 19th Street NW, Naples, Florida, 34120.
- 3. PURPOSES: The general purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida, except as is inconsistent with the express provisions of these Articles.
- 4. SHARES: The corporation is authorized to issue one hundred (100) shares of common stock, all of one class, at one dollar (\$1.00) par value.

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
- **6. REGISTERED OFFICE AND AGENT**: The street address of the registered office shall be 4820 Bayshore Drive, Suite F, Naples, Florida, 34112, and the name of the registered agent at such address shall be Wendy H. Girardin, Esquire.
- 7. TERM OF EXISTENCE: This corporation is to exist perpetually.
- 8. EFFECTIVE DATE: This corporation shall have an effective date of April 13, 1998.
