The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be SYMMETRY SYSTEMS, INC. The address of the principal office of the corporation and the mailing address of the corporation is 1149 Buckbean Branch Lane East, Jacksonville, Florida, 32259.

ARTICLE II

The duration of the corporation shall be perpetual.
