ARTICLES OF INCORPORATION **OF**

PARENT-CHILD DEVELOPMENTAL CLINIC, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to the contract and hereby forms a corporation for profit under chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is PARENT-CHILD DEVELOPMENTAL CLINIC, INC.

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE 3 - PRINCIPAL OFFICE

ARTICLE 4 - INCORPORATOR

ARTICLE 5 - PRESIDENT

The initial president of the corporation shall be Claiborne Christian whose address shall be the same as the principal office of the corporation.

ARTICLE 6 - CORPORATE CAPITALIZATION

- The maximum number of shares that this corporation is authorized to have outstanding at any time is TWO THOUSAND FIVE HUNDRED (2500) shares of common stock, each having the par value of ONE DOLLAR (\$1.00).
