### Article I - Name

The name of the corporation is The New Curve, Inc.

# Article II -Duration

This Corporation shall have perpetual existence.

### Article III - Purpose

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida

### Article IV - Capital Stock

The total authorized capital stock of the Corporation shall consist of One Thousand (1,000) shares of common stock having a par value of One and No/100's (\$1.00) dollars each, amounting in the aggregate to One Thousand (\$1,000.00) Dollars.

# Article IX - By-Laws

Any Director individually, or any firm which any director may be a member, may be a part to, or may be pecuniarily or otherwise interested in, any contract or transaction of this Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors.
