

THE UNDERSIGNED SUBSCRIBER to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida:

ARTICLE I - NAME AND ADDRESS

The name of this Corporation is:

ARTICLE II - DURATION

This Corporation shall have perpetual existence, commencing on the date of execution of these Articles by the Incorporator.

ARTICLE III - PURPOSES AND POWERS

This Corporation is organized for the purpose of installing, replacing, constructing, fabricating, removing, customizing, designing, creating, embellishing, marketing, selling, purchasing, exchanging and otherwise dealing with wood and wood products and all goods and services related thereto. 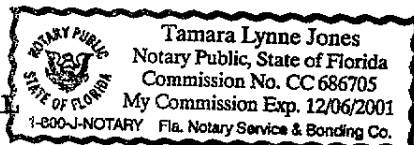
