The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I.

NAME: The name of this corporation shall be J & B Level Line, Inc.

ARTICLE II.

ARTICLE III.

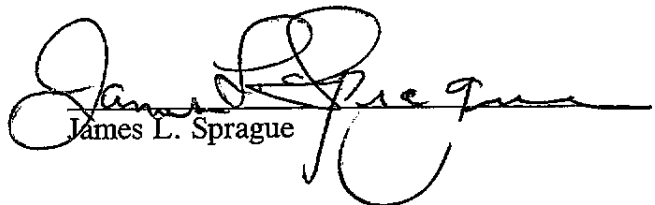
ARTICLE X.
