ARTICLES OF INCORPORATION

FOR

AVICENNA, INC.



The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is Avicenna, Inc.
