KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporator does hereby incorporate a corporation under the provision of Chapter 607, Florida Statutes for the transaction of business with and under the following Articles of Incorporation:

EFFECTIVE DATE

4-1-98

ARTICLE I

The name of the corporation shall be and is R.L.R. PAINTING, INC. located at 1819 WILTON AVE. ORLANDO, FL 32805.

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is APRIL 1, 1998.

ARTICLE III

The general purposes for which the corporation is initially organized are as follows:

- A. Painting of buildings both interior and exterior.
- B. To transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

- A. The aggregate number of shares which the corporation shall have authority to issue is 5,000, all of which shall be of one and the same class and each of which shall be of \$0.00 par value.
- B. All or any portion of the capital stock may be issued in payment for real or personal property, services, or any other right or thing having a value, in the judgment of the Board of Directors, at least equivalent to the full value of the stock so to be issued as hereinabove set forth, and when so issued shall become and be fully paid and non-assessable, the same as though paid for in cash; and the directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock, and their judgment of such value shall be conclusive.
- C. Notwithstanding the foregoing, the corporation shall have the right to increase its capital stock either with or without par value, and to provide in the event of such increases the designations, preferences, voting powers or

restrictions, or qualification of voting powers, of such additional stock, in an amendment to its Certificate of Incorporation.

ARTICLE V

The street address of the corporation's initial registered office is 1819 WILTON AVE. ORLANDO, FL 32805. The name of the corporation's initial registered agent at that address is RICHARD LEE RENSHAW

ARTICLE VI

There shall be ONE (1) Director and Officer constituting the initial Board of Directors of the corporation. The name and address of the person who is to serve as member of the initial Board of Directors is as follows:

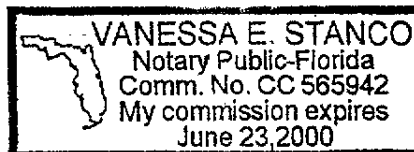
