KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporator does hereby incorporate a corporation under the provision of Chapter 607, Florida Statutes for the transaction of business with and under the following Articles of EFFECTIVE DATE Incorporation: 4-1-98

ARTICLE I

The name of the corporation shall be and is R.L.R. PAINTING, INC. located at 1819 WILTON AVE. ORLANDO, FL 32805.

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is APRIL 1, 1998.

ARTICLE III

The general purposes for which the corporation is initially organized are as follows:
