Pursuant to the Provisions of Section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted:

Change Article III in its entirety to read as follows:

ARTICLE III: The maximum number of shares of capital stock which the corporation is authorized to have outstanding at any time is one thousand (1000) shares of common stock with a par value of One Tenth dollar (\$.10) per share.

SECOND: Blank intentionally

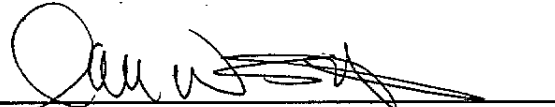
THIRD: Amendment Adoption:
