ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be IK FINE ART JEWELRY, INC.

DURATION OF CORPORATION

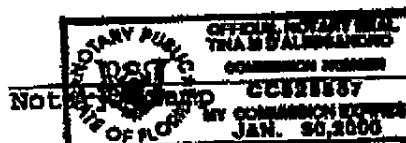


