**ARTICLE I - NAME**

The name of this corporation is **GANCEDO SUPER SWEEP, INC.**

The Principal Place of business is 7251 S.W. 23rd St., Miami, Fl. 33155

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

**ARTICLE III - PURPOSE**

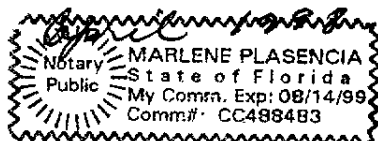

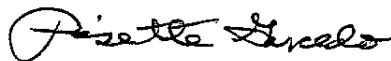
