ARTICLES OF INCORPORATION OF ZADEN & WARDELL, P.A., a Florida Corporation

The undersigned, acting as incorporator of a Florida Professional Service Corporation under the Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

<u>NAME</u>
