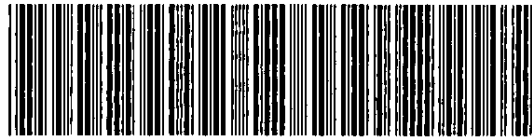

On May 5<sup>th</sup> 2009 without my knowledge my husband and business partner of 21 years, Richard D. Esola, license # CGC059273 resigned as the qualifier for Esola Contracting Enterprises Inc. He has qualified for at least 1 other co. Hurricane glass shield located in Sarasota, FL.

On that application he stated that he was 51% owner of Esola Contracting and that he was not bankrupt. Richard is 49% owner of our co. and we declared bankruptcy on Dec 21st 2007 which was discharged in June of 2008. I believe he was fingerprinted and you granted him the qualifying license.

\*\*\*\*I am writing to you now to please help me close this company completely as I was only made 51% owner because my husband wanted to have a minority rights ability as a woman owner. He has had control of our co. without my ability to even know what work was being contracted for more than 2 years as I have had a full time job for that long. He has been reckless and had no integrity for the company or our family in as long too. He has disappeared from our company and our home and family. He had shut me out of all company records and company or personal banking in January 2009 as well as our warehouse with all our company's assets.

I have no money to hire an attorney and am left unable to even save my home which is being foreclosed on soon and I was unaware he was not compiling with the banks either. I beg you to help me close this company completely and dissolve the QB#QB27433 Fictitious name #G972722700029

I know that he is sending out resumes and filling out credit cards stating that he is the owner of this company dated as 5-21-09. I received a phone call for verification of this. I wish I could attach this information on his credit report as to stop the fraud.

One last thing is he was using a P.O. Box # for a physical address
