The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

ARTICLE II - DURATION

- This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
