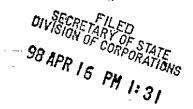

ARTICLES OF INCORPORATION OF EXPERT MEDICAL LETTERS, INC.

ARTICLE I - NAME

The name of this corporation is EXPERT MEDICAL LETTERS, Inc.

ARTICLE II - TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time if filing of these Articles of Incorporation by the Department of State.

ARTICLE III - CORPORATE PURPOSE

The corporation may engage in ant activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - AUTHORIZED SHARES

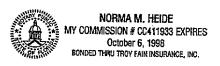
