ARTICLES OF INCORPORATION OF N.A.R. ENTERPRISES, INC.

The undersigned subscribers to these ARTICLES OF INCORPORATION is a natural person competent to contract and hereby form a corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the corporation is N.A.R. ENTERPRISES, INC.

ARTICLE 2 - PURPOSE OF CORPORATION

The corporation shall engage in any activity or business permitted under the laws of the UNITED STATES and the STATE OF FLORIDA.

ARTICLE 3 - PRINCIPAL OFFICE

ARTICLE 4 - INCORPORATORS
