

ARTICLES OF INCORPORATION OF JR PINECREST, INC.

The undersigned incorporator, for the purpose of forming a corporation pursuant to the laws of the State of Florida, Florida Statutes, Chapter 607, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is JR PINECREST, INC., a Florida corporation.

ARTICLE II - ADDRESS

The initial mailing address of the Corporation is 9050 Pines Boulevard, Suite 250, Pembroke Pines, Florida 33024.

ARTICLE III - PURPOSE
