ARTICLES OF INCORPORATION

OF

DEER CREEK MFG. HOUSING SALES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: DEER CREEK MFG. HOUSING SALES, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: #10 SW WHITETAIL PLACE, LAKE CITY, FLORIDA 32055

ARTICLE III. DURATION

The duration of this corporation is perpetual.

ARTICLE IV. PURPOSE
