Dear Reinstatement Officer:

I am requesting the waiver of the late filing and reinstatement penalty for our 1999 Annual Report due to a series of events unfamiliar to me.

In April 1998 I engaged the Florida law firm of Zhang and Pedersen to form Oriental Pacific Inc. At that time, the law firm made arrangement to have our corporate and mailing address located at 3389 Sheridan Street, #129, Hollywood, Florida 33021. When I arrived in the U.S. in December of 1998, I set up my office at 6801 NW 77 Avenue, Suite 306C, Miami, Florida 33166. After my landlord informed me that our company has lost corporate status today, I started to trace the problem. I then discovered that the Sheridan address was only a mail-box facility which probably was closed in July of 1998 after our incorporation. Our company never received the annual report nor did our attorney advise us that the Sheridan address was not available for use. Our attorney has also relocated to another state which makes placing responsibility difficult. My guess is that the mail-box operator did not care to forward the annual report notices.

I recognize that it is the corporate officers' responsibility to follow-up with all required filings. However, that neglected annual report was our first and we were ill-advised.

Thank you for reviewing this abatement request. The reinstatement form and the regular annual report fee of \$150.00 is enclosed.
