**ARTICLES OF INCORPORATION**

**OF**

**MICHELLE LOWER, C.R.N.A., P.A.**

The undersigned, acting as the incorporator under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is Michelle Lower, C.R.N.A., P.A. (the "Corporation").
2. The principal place of business of the Corporation shall be:

3. The Corporation is authorized to issue 1,000 shares of common stock, which shares collectively shall have unlimited voting rights and the right to receive the net assets of the corporation upon dissolution.

Any repeal or modification of the foregoing provisions of this Section 11 by the shareholders of the corporation shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.
