

ARTICLES OF INCORPORATION

OF

ASP INDUSTRIES, INC.

The undersigned, for the purpose of forming a corporation under the State of Florida General Corporation Act, does hereby adopt the following Articles of Corporation.

ARTICLE I

NAME

The name of the corporation is: ASP INDUSTRIES, INC.

ARTICLE II

DURATION

This corporation shall commence its existence upon filing Articles and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the State of Florida.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 50,000,000 shares of \$.01 par value common stock, which shall be designated as "Common Shares". All of said stock shall be payable in cash, property (real or personal) or labor or services in leiu thereof at just valuation to be fixed by the board of Directors.
