The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is West Coast Imperial, Inc. and its principal office and mailing address is 1245 Blackrush Drive, Tarpon Springs, FL 34689.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on April 15, 1998.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

Capital Stock

By-Laws


