ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of BOCA RATON WEST HOSPITALITY CORP.

- 1. Articles Seventh, Eighth, Ninth, Tenth and Eleventh of the Articles of Incorporation, added by Amendment dated July 22, 2001, are deleted in their entirety.
- 2. Article Sixth of the Articles of Incorporation, added by Amendment dated July 22, 2001, is deleted in its entirety and replaced with the following:

If Florida law is amended after the date of filing of these Articles of Amendment to authorize corporate action further eliminating or limiting the personal liability of Directors, then the liability of Directors of the corporation will be eliminated or limited to the fullest extent permitted by Florida law, as so amended. No repeal or modification of this Article Sixth will apply to or have any effect on the liability or alleged liability of any Director of the corporation for or with respect to any acts or omissions of such Director occurring prior to such repeal or modification."

3. The date of adoption of this amendment was February 17, 2017.
