ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of BOCA RATON EAST HOSPITALITY CORP.



Pursuant to the provisions of section 607.1006, Florida Statutes, the undersigned Corporation adopts the following articles of amendment to its articles of incorporation.

- 1. Articles Seventh, Eighth, Ninth, Tenth and Eleventh of the Articles of Incorporation, added by Amendment dated July 22, 2001, are deleted in their entirety.
- 2. Article Sixth of the Articles of Incorporation, added by Amendment dated July 22, 2001, is deleted in its entirety and replaced with the following:
