**ARTICLES OF INCORPORATION
OF
KIRSTEN WOODRUFF, P.A.**

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a professional service corporation (the "**Corporation**") under the Florida Business Corporation Act (the "**Act**") and the Florida Professional Service Corporation and Limited Liability Company Act, as follows:

ARTICLE 1

Name

The name of the Corporation is **KIRSTEN WOODRUFF, P.A.**

ARTICLE 2

Term of Existence/Specific Purpose

The date when corporate existence will commence is May 1, 1998 in accordance with the provisions of Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter. The specific nature of business is to practice law.

ARTICLE 3

Principal Office

The principal office and mailing address of the Corporation is 100 South Ashley Drive, Suite 2100, Tampa, Florida 33602.

ARTICLE 4

Capital Stock

The Corporation is authorized to issue 1,000 shares of \$0.01 par value common stock, which will be designated Common Stock.

ARTICLE 5
