The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of incorporation for such corporation:

- 1. Name of Corporation. The name of this corporation shall be Fenton and Gillombardo Associates, P.A.
- 2. Duration. The period of its duration is perpetual.
- 3. <u>Purposes</u>. The purpose is to provide mental health care services permitted under the laws of the United States and Florida.
- 4. <u>Capital Stock</u>. The corporation is authorized to issue 100 shares, all of one class common stock, at no par value each.
