ARTICLES OF INCORPORATION

OF

TAITTINGER GROUP, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is TAITTINGER GROUP, INC., whose principal place of business is 7491 N. Federal Highway C-5, Suite, 182, Boca Raton, Florida, 33431.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.
