ARTICLES OF INCORPORATION

The undersigned incorporator for purposes of forming a professional service corporation under Section 621.05, Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is OSCAR RIVERO, P.A. (the "Corporation").

SECOND: The street address of the initial principal office and mailing address of the Corporation is: 2601 South Bayshore Drive, Suite 1600, Miami, Florida 33133.

THIRD: The Corporation is authorized to issue 10,000 shares of common stock, par value \$1.00 per share.
