Eleazar Gadea

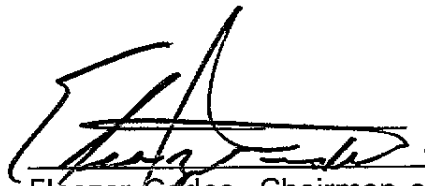
