whose addresses shall be the same as the principal address of the Corporation.

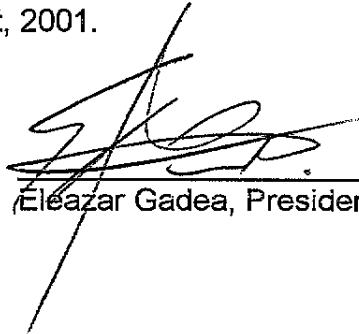
FIFTH: The amendment does not provide for an exchange, reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained in the amendment itself.

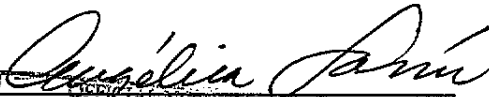
